#### OVERVIEW

A Certificate of Occupancy (C of O) proves that the bearer is the property's legitimate owner. Individuals and businesses may register their property with Taraba Geographic Information Services (TAGIS) in compliance with Section 13(1) of the Taraba State Geographic Information Service Establishment Law & Other Related Matters Therewith 2024. The following instructions must be followed in order to apply for and register a property with TAGIS in order to receive a C of O:

# 1. Indexing:

- Owner type (e.g., corporate entity/private individual).
- Owner(s) name.
- Owner(s) gender.
- Ownership type (e.g., single-owned; joint/co-owned between man and woman).
- Property unique ID.
- CofO issuance date.
- CofO registration date.
- CofO reference number (matching the physical record number)

# 2. Scanning and Archiving:

• Raw File format: TIFF/JPEG Standard.

File format: PDF.Resolution: 200 dpi.

• Colour depth: 1-bit bi-tonal (B/W) and 24-bitcolour.

- 3. System Security and Privacy:
  - JSON web token for authentication within an API interface.
  - Strict storage of tokens in cookies with enforced security measures.
  - Utilization of HTTPS/encryption protocols.
